**Debit Authorization**

The undersigned payer(s) hereby authorize(s) and direct(s) First National Bank Alaska (FNBA) to initiate debit entries to the deposit account of the undersigned payer(s) identified below, and authorize(s) and directs the financial institution maintaining the deposit account to permit withdrawal of available credit in accordance with debit entries initiated by FNBA pursuant to this DEBIT AUTHORIZATION. **The undersigned further agree(s) with FNBA as follows:**

1. **No debit entry will be initiated by FNBA if a payment due according to the escrow instructions is delinquent or the next payment is due sooner than ten (10) business days after FNBA's acceptance below.** The undersigned will continue to make payment by other means until receipt of written notice from FNBA of the date of the first debit to be initiated by FNBA following its acceptance below.
2. FNBA is authorized to effect debit entries until:
  - the maturity date, or date the final installment payment becomes due;
  - a notice of Change of Payer is received by FNBA; or
  - a written notice executed by the undersigned, revoking the authority granted hereby, is received by FNBA's Escrow Department at least ten (10) business days before the next scheduled payment is due.
3. FNBA may stop making debit entries anytime, without prior notice to the undersigned, if a debit entry is rejected, returned, dishonored, or reversed by the financial institution maintaining the deposit account. FNBA is not obliged to furnish notice of its termination of this service for any of those reasons, and the undersigned will satisfy the resulting unpaid installment(s) by some other means.
