Trustor is in default as payment of the Promissory Note is four months or more past due and late charges are also past due in the amount of \$454.20.

Beneficiary may enter a credit offset bid consisting of sums due it under the deed of trust security agreement and Promissory Note. Title to the real property will be conveyed by trustee's quitclaim deed without warranties of title.

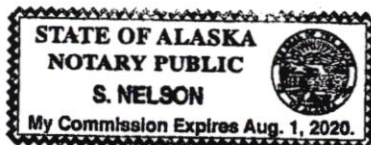
