NOTICE OF DEFAULT AND DEED OF TRUST FORECLOSURE SALE

Trustor is in default as payment of the secured note is 26 months or more past due and late charges are also past due in the amount of \$1,559.64.

The amount due and owing by Trustor to the Assignee of the Beneficiary as of September 22, 2021 is \$196,810.72, which includes \$167,288.55 in principal, \$17,214.41 in interest from May 1, 2019, \$1,559.64 in late charges, \$8,713.12 in escrow reserve, \$45.00 for a Trustee's Sale Guarantee, \$90.00 recording costs, \$300.00 Trustee Corps, and \$1,600.00 attorney fees. This balance will continue to accrue interest after September 22, 2021 at a rate in accordance with the Note until the time of sale. YOU ARE NOTIFIED that MTC Financial Inc. d/b/a Trustee Corps., Trustee, by demand of Assignee, hereby elects to sell the real property described above to satisfy the obligations secured thereby at an auction sale to be held on January 5, 2022, in the main lobby of the Boney Courthouse at 303 K Street, Anchorage, Alaska. Payment must be made at the time of sale in cash or by cashier's check. Assignee may enter a credit offset bid consisting of sums due it under the deed of trust security agreement and note. Title to the real property will be conveyed by trustee's quitclaim deed without warranties of title.

YOU ARE FURTHER NOTIFIED that if default has arisen by failure to make payments required under the Promissory Note and/or the deed of trust, the default may be cured and this sale terminated if (1) payment of the sum then in default, other than principal that would not then




